# Introduction

Thank you for purchasing a Guardian Fall Protection Edge Angel SRL. This manual must be read and understood in its entirety, and used as part of an employee training program as required by OSHA or any applicable state agency.

This and any other included instructions must be made available to the user of the equipment. The user must understand how to safely and effectively use the Edge Angel SRL, and all fall safety equipment used in combination with the Edge Angel SRL.

# **Applicable Safety Standards**

When used according to instruction specifications, this product meets or exceeds all applicable OSHA 1926 Subpart M, OSHA 1910, ANSI Z359.14-2012, and ANSI A10.32-2012 standards for fall protection. Applicable standards and regulations depend on the type of work being done, and also might include state-specific regulations. Consult regulatory agencies for more information on fall protection systems and associated components.

## **Worker Classifications**

CAUTION

Understand the following definitions of those who work near or who may be exposed to fall hazards.

**Qualified Person:** A person with an accredited degree or certification, and with extensive experience or sufficient professional standing, who is considered proficient in planning and reviewing the conformity of fall protection and rescue systems.

**Competent Person:** A highly trained and experienced person who is ASSIGNED BY THE EMPLOYER to be responsible for all elements of a fall safety program, including, but not limited to, its regulation, management, and application. A person who is proficient in identifying existing and predictable fall hazards, and who has the authority to stop work in order to eliminate hazards.

Authorized Person: A person who is assigned by their employer to work around or be subject to potential or existing fall hazards.

It is the responsibility of a Qualified or Competent person to supervise the job site and ensure all applicable safety regulations are complied with.



# **Product Specific Applications**

**WARNING** Use of equipment in unintended applications may result in serious injury or death. Maximum 1 attachment per connection point.

**Personal Fall Arrest:** Edge Angel SRLs may be used to support a MAXIMUM 1 Personal Fall Arrest System (PFAS) for use in Fall Arrest applications. Structure must withstand loads applied in the directions permitted by the system of at least 5,000 lbs. Maximum free fall is 2'. SRL may be positioned a maximum 2' above anchor point. Applicable D-ring: Dorsal.



**Restraint:** Edge Angel SRL may be used in Restraint applications. Restraint systems prevent workers from reaching the leading edge of a fall hazard. Always account for fully deployed length of lanyard/SRL. Structure must withstand loads applied in the directions permitted by the system of at least 1,000 lbs. No free fall is permitted. Restraint systems may only be used on surfaces with slopes up to 4/12 (vertical/horizontal). Applicable D-rings: Dorsal, Chest, Side, Shoulder.

For all applications: worker weight capacity range (including all clothing, tools, and equipment) is 130-420 lbs.

# Limitations

Fall Clearance: There must be sufficient clearance below the anchorage connector to arrest a fall before the user strikes the ground or an obstruction. When calculating fall clearance, account for a MINIMUM 3' safety factor, deceleration distance, user height, length of lanyard/SRL, and all other applicable factors.

# Diagram shown is an example fall clearance calculation ONLY.

Swing Falls: Prior to installation or use, make considerations for eliminating or minimizing all swing fall hazards. Swing falls occur when the anchor is not directly above the location where a fall occurs. Always work as close to in line with the anchor point as possible. Swing falls significantly increase the likelihood of serious injury or death in the event of a fall.

Compatibility: When making connections with Edge Angel SRL, eliminate all possibility of roll-out. Roll-out occurs when interference between a hook and the attachment point causes the hook gate to unintentionally open and release. All connections must be selected and deemed compatible with Edge Angel SRL by a Competent Person, All connector gates must be self-closing and self-locking, and withstand minimum loads of 3,600 lbs. See the following for examples of compatible/incompatible connections:

Connector closed and locked to D-ring. OK.

Two connectors to same D-ring. NO.



Two or more snap hooks or carabiners connected to each other. NO.













Connector to integral lanyard. NO.

Connector directly to webbing. NO.

Connector directly to horizontal lifeline. NO.


# **Components and Specifications**

Materials: aluminum, galvanized steel, stainless steel, zinc-plated steel, polyester, and nylon.

Class B SRL. Average arrest force: 900 lbs. Maximum arrest force:1,800 lbs. Maximum deceleration distance: 54".

# Installation and Use

1. All PFAS components must be selected and deemed compatible with Edge Angel SRL by Competent Person.

2. Ensure structure to which Edge Angel SRL is to be attached, and on which work is to be performed, is free of all hazards, including, but not limited to, debris, rot, rust, sharp or abrasive edges and surfaces, and hazardous materials.

3. Eliminate or minimize all risk of swing fall hazard.

4. Edge Angel SRL may be used in either stationary or mobile applications. For stationary mode, attach Edge Angel SRL carabiner to selected anchorage connector, and attach snap hook to applicable harness D-ring. Edge Angel SRL must be used in stationary mode when used in LE applications (shock absorber end must be connected to harness dorsal D-ring). For mobile mode, attach Edge Angel SRL carabiner to applicable harness D-ring, and attach snap hook to selected anchorage connector.

5. Ensure 100% tie-off will be maintained at all times, which may require the use of a back-up or supplementary fall protection system.

#### LE SRL Additional Use Instructions:

WARNING

**ING** ALWAYS adhere to the following warnings and specifications when using LE SRLs.

Edge Angel SRLs are tested and certified for horizontal use over a steel edge without burrs. Edge Angel SRLs may be used over similar surfaces, such as metal sheeting or other steel formations.

The allowable angle of redirection of the lifeline portion of Edge Angel SRLs at the leading edge of a fall hazard MUST be at least 90° (see Image 1).

Anchor point MUST be situated no lower than the leading edge of applicable fall hazard(s).

Prior to use, a Competent Person MUST calculate adequate fall clearance (see pg. 2).

ALWAYS attach to anchorage connector that will allow for required setback distance (see Image 2).


Setback distance: As determined by product testing, Guardian Fall Protection Edge Angel SRLs MUST be installed a MINIMUM 6' (1.8m) from the leading edge of applicable fall hazard(s).



Edge Angel SRL may be used in combination with horizontal lifelines. All installation, set-up, and use of horizontal lifelines must be done under the supervision of a Qualified Person.

NEVER work on the far side of an opening that is opposite the Edge Angel SRL anchorage point.

In the event of a fall over the edge, special rescue measures may be necessary. Always account for use of Edge Angel SRL in job site rescue plan developed by job site Competent Person.



### Maintenance, Cleaning, and Storage

If Edge Angel SRL fails inspection in any way, immediately remove it from service, and contact Guardian to inquire about its return or repair.

Cleaning after use is important for maintaining the safety and longevity of Edge Angel SRL. Remove all dirt, corrosives, and contaminants from Edge Angel SRL before and after each use. If Edge Angel SRL cannot be cleaned with plain water, use mild soap and water, then rinse and wipe dry. NEVER clean Edge Angel SRL with corrosive substances.

When not in use, store equipment where it will not be affected by heat, light, excessive moisture, chemicals, or other degrading elements.

### Inspection

Prior to EACH use, inspect Edge Angel SRL for deficiencies, including, but not limited to, corrosion, deformation, pits, burrs, rough surfaces, sharp edges, cracking, rust, paint buildup, excessive heating, alteration, broken stitching, fraying, bird-caging, and missing or illegible labels. IMMEDIATELY remove Edge Angel SRL from service if defects or damage are found, or if exposed to forces of fall arrest.

Ensure that applicable work area is free of all damage, including, but not limited to, debris, rot, rust, decay, cracking, and hazardous materials. Ensure that selected work area will support the application-specific minimum loads set forth in this instruction manual. Work area MUST be stable.

At least every 6 months, a Competent Person other than the user must inspect Edge Angel SRL. **Competent Person inspections MUST be recorded in inspection log in instruction manual and on equipment inspection grid label.** The Competent Person must sign their initials in the box corresponding to the month and year the inspection took place.

During inspection, consider all applications and hazards Edge Angel SRL has been subjected to.



# **Inspection Log**

Product lifetime is 5 years from date of first use, or, if date of first use is not recorded, from date of manufacture, as long as it passes pre-use and Competent Person inspections. User must inspect prior to EACH use. Competent Person other than user must complete formal inspection at least every 6 months. Competent Person to inspect and initial.

This inspection log must be specific to one Edge Angel SRL. Separate inspection logs must be used for each Edge Angel SRL. All inspection records must be made visible and available to all users at all times.

# Safety Information



Failure to understand and comply with safety regulations may result in serious injury or death. Regulations included herein are not all-inclusive, are for reference only, and are not intended to replace a Competent Person's judgment or knowledge of federal or state standards.

Do not alter equipment. Do not misuse equipment.

Workplace conditions, including, but not limited to, flame, corrosive chemicals, electrical shock, sharp objects, machinery, abrasive substances, weather conditions, and uneven surfaces, must be assessed by a Competent Person before fall protection equipment is selected.

The analysis of the workplace must anticipate where workers will be performing their duties, the routes they will take to reach their work, and the potential and existing fall hazards they may be exposed to. Fall protection equipment must be chosen by a Competent Person. Selections must account for all potential hazardous workplace conditions. All fall protection equipment should be purchased new and in an unused condition.

Fall protection systems must be selected and installed under the supervision of a Competent Person, and used in a compliant manner. Fall protection systems must be designed in a manner compliant with all federal, state, and safety regulations. Forces applied to anchors must be calculated by a Competent Person.

Unless explicitly stated otherwise, the maximum allowable free fall distance for lanyards must not exceed 6'. No free fall allowed for non-LE SRLs. Class A SRLs must arrest falls within 24"; Class B SRLs must arrest falls within 54".

Harnesses and connectors selected must be compliant with manufacturer's instructions, and must be of compatible size and configuration. Snap hooks, carabiners, and other connectors must be selected and applied in a compatible fashion. All risk of disengagement must be eliminated. All snap hooks and carabiners must be self-locking and self-closing, and must never be connected to each other.



A pre-planned rescue procedure in the case of a fall is required. The rescue plan must be project-specific. The rescue plan must allow for employees to rescue themselves, or provide an alternative means for their prompt rescue. Store rescue equipment in an easily accessible and clearly marked area.

Training of Authorized Persons to correctly erect, disassemble, inspect, maintain, store, and use equipment must be provided by a Competent Person. Training must include the ability to recognize fall hazards, minimize the likelihood of fall hazards, and the correct use of personal fall arrest systems.

NEVER use fall protection equipment of any kind to hang, lift, support, or hoist tools or equipment, unless explicitly certified for such use.

Equipment subjected to forces of fall arrest must immediately be removed from use.

Age, fitness, and health conditions can seriously affect the worker should a fall occur. Consult a doctor if there is any reason to doubt a user's ability to withstand and safely absorb fall arrest forces or perform set-up of equipment. Pregnant women and minors must not use this equipment.

Physical harm may still occur even if fall safety equipment functions correctly. Sustained post-fall suspension may result in serious injury or death. Use trauma relief straps to reduce the effects of suspension trauma.

### Labels
